

A question for California Attorney General Bill Lockyer:

Mr. Attorney General, who wants you to grant Irving Moskowitz a casino license?

- ✓ **Not the people of Hawaiian Gardens**, where Moskowitz built his casino with \$12 million in public funds—precious dollars representing life chances for the city's poor, predominantly Latino residents.
- ✓ **Not the Israeli peace movement**, whose members have joined Palestinians protesting Moskowitz's housing projects, which are strategically placed in hypersensitive areas of Jerusalem to frustrate the peace process. (Moskowitz gets some of the funds to buy Jerusalem property from a bingo parlor he runs in Hawaiian Gardens.)
- ✓ **Not the mainstream of American Jews!** The Central Conference of American Rabbis, the largest rabbinical body in the US, passed by acclamation a "vigorous" protest of "the Moskowitz Foundation's documented methods of political manipulation and labor exploitation perpetrated against the impoverished community of Hawaiian Gardens, utilizing ill-gained profits from gambling for the apparent purpose of funding anti-peace agitation in the Holy City of Jerusalem." The Board of Directors of Temple Israel of Long Beach has asked Lockyer to reject Moskowitz's license application.
- ✓ **Not community leaders or activists**, who care about the future of the people of Hawaiian Gardens, and who support Israeli-Palestinian peace.

Attorney General Lockyer, we say please don't grant Moskowitz a casino license!
